PART A OVERVIEW

A Vision for the Facilities Management Industry

Background

Following representations by the Facility Management Association of Australia (FMA Australia) on behalf of the industry, the Australian Government announced the Facilities Management (FM) Action Agenda on 19 January 2004.

The Minister for Industry, Tourism and Resources, the Hon Ian Macfarlane MP appointed a Strategic Industry Leaders Group (SILG) which first met on 31 March 2004. Chaired by John McCarthy the SILG consisting of 15 representatives with expertise across a wide range of the facilities management industry. The SILG determined the need to raise the awareness about the facilities management industry and in April 2005 published a strategic plan with a 20 point action plan for industry recognition and development. The plan was entitled 'FM Action Agenda: Managing the Built Environment' and identified the following five focus areas;

- innovation
- education & training
- regulatory reform
- sustainability
- communications

The SILG resolved to create an FM Exemplar Project to research and selected Sydney Opera House and engaged with the CRC for Construction Innovation to achieve innovative FM strategies and models that will showcase improved FM performance and promote best practice.

In August 2005 the Hon Ian Macfarlane MP appointed the FM Action Agenda Implementation Board with John McCarthy as Chairman and Stephen Ballesty as Deputy Chairman. The Board is comprised of a number of members from the former SILG members and additional industry leaders who collectively represent a wide cross-section of the industry and have both the expertise and commitment to drive the FM Action Agenda throughout the implementation phase.


Industry and Government Collaboration

FM ACTION AGENDA IMPLEMENTATION PHASE

The FM Action Agenda represented a unique collaboration between FM industry participants, the Australian Government and FMA Australia. The 36 month implementation phase commenced in 2005, and concluded on 30 June 2008, and was the responsibility of the FM Action Agenda Implementation Board.

The Implementation Board has maintained its stakeholder diversity and met at least quarterly for the past three (3) years with 12 Ministerial appointed volunteer industry leaders plus Government representatives and an FMA Australia secretariat. The Board has adhered to the FM Action Agenda's 2005 strategy and 20 point action plan, with some minor scope modifications and / or redefined the deliverables in response to market conditions.

The implementation phase has taken a multi-pronged approach to enhancing the recognition of the FM industry and removing impediments to its growth across the following platforms as four (4) Recognition Working Groups:

- Innovation Improved appreciation of facility life cycles, greater understanding of the key drivers of workplace productivity, and the improved application of information technology.
- Education and Training Improved access to dedicated FM education and training opportunities and creating clear career pathways into the profession.
- Regulatory Reform Explore opportunities to harmonise cross jurisdictional regulatory compliance requirements that have an efficiency impact on FM.
- Sustainability Improved utilisation of existing knowledge and the development of tools and opportunities to improve the environmental performance of facilities.

A Communications Working Group has also been maintained with the dual liaison objectives of internal co-ordinations and external promotions. Each of these five (5) groups have been lead by Board members and resourced by energetic industry volunteers. In Year 3 these groups have involved some 55 individuals from 52 organisations.

In addition the Implementation Board committed to the completion of the FM Exemplar Project: Sydney Opera House as scoped with the CRC for Construction Innovation, together with selected research and industry partners involving some 25 individuals from 10 organisations. During 2007 the FM Exemplar Project published two (2) research study summary reports; 'FM as a business enabler' and 'Adopting BIM for facilities management', and received multiple industry awards.

This third annual and concluding report details the FM Action Agenda's progress and achievements during 2007-08, together with a Transition Plan so that others can continue the FM Action Agenda legacy.



Facilities Management in the Australian Economy

The statistical profile of the Facilities Management industry's contribution to the Australian economy as prepared by Access Economics in 2004, was updated with 2005-06 data and released in September 2007.

This report which identified FM activities was concerned only with the servicing of buildings as provided by both in-house FM personnel and outsourced FM service contractors. Business specific operating costs of facility occupants were excluded. Access Economics found the boundaries of the industry were not precisely defined. For example, while all servicing of buildings used by educational and hospital facilities have the potential to be covered by FM contracts, there is some arbitrariness in deciding where to draw the boundaries on the sizes of office buildings, retail centres and multi-unit residential buildings that are to be included. As a general rule, where Access Economics has had to make a judgement on these matters, they generally erred on the side of understating the size of the FM industry.

The Australian FM industry directly accounted for \$8.2 billion of gross value added, \$8.4 billion of GDP, and the (full time equivalent) employment of about 112,000 persons in 2005-06. The direct results include both FM management and FM service suppliers. This represents 0.9%, 0.9% and 1.3% of the corresponding gross value added, GDP and employment totals for the Australian economy.

In addition, the FM industry indirectly contributed \$5.4 billion of value added and \$5.5 billion of GDP, and accounted for indirect (full time equivalent) employment of 68,000 persons. Combining the direct and indirect contributions, in 2005-06 the FM industry contributed \$13.6 billion of value added, \$13.9 billion in GDP, and (full time equivalent) employment of 180,000 persons. The combined contribution represents 1.5%, 1.4% and 2.1% of the corresponding gross value added, GDP and employment for Australia.

Communications



2006 saw the launch of the FM Action Agenda's distinctive logo, depicting the intrinsic integration of the natural and built environments. The FM Action Agenda's independence and commitment to information was demonstrated with the

establishment of our own dedicated website www.fmactionagenda.org

Industry presentations and media releases continue to profile our unique collaboration between government and industry, both here and abroad, and during the 2007-08 year alone the achievements of the FM Action Agenda and findings of the FM Exemplar Project: Sydney Opera House have been presented to industry audiences in Brisbane, Gold Coast, Melbourne, Sydney, and internationally in Atlanta, Beijing, Calgary, Copenhagen, Kuala Lumpur, New Orleans, Sacramento, Seoul, Manchester, Phoenix, Shanghai and Singapore, with presentations being confirmed for the latter half of 2008 in Beijing, Dallas and Sydney. The FM Action Agenda has also achieved a significant profile in many media outlets and publications including a regular feature in FMA Australia's Facility Perspectives quarterly magazine.

Innovation

The FM Action Agenda web portal was launched at the FMA Australia's annual conference, ide**a**ction 2006, in Canberra. Following on from a web-based FM Innovation survey in February 2007, this Recognition Working Group identified focus topics for the development of an FM Innovation Forum. FMA Australia hosted an Innovation Round Table breakfast at ide**a**ction 2007 in Sydney, allowing industry leaders to exchange ideas on potential research projects. The survey findings and outcomes of these collaborations was a clearly defined need for FM Innovation focused on services procurement, workplace productivity and sustainable environments.

Key themes which have been progressed by our Project Delivery Teams with a view to developing industry guideline publications have included;

- Services Procurement in the FM marketplace as an issue substantially expressed in financial terms and yet has a huge multiplier in terms of environmental and social impact. Therefore, it is vital that the FM industry moves towards implementing sustainable procurement principles that establish relationships and commercial models where contractors are encouraged to focus on long term productivity and sustainability objectives. Research has been undertaken focusing on such relationships and models considering risk-reward mechanisms and associated key performance indicators structured to encourage improved behaviours and stimulate innovation.
- Workplace Productivity and the benefits associated with improved indoor ecology, reflecting the
 increasing corporate, government and industry association interest in this vital area and
 its potential economic contribution. A project has now been established which assesses the
 productivity measurement methodology obtained from the Healthy Buildings Forum in Lisbon,
 Portugal against recent productivity case studies undertaken in projects across Australia. The
 result of this project will be published as performance measures and best practice benchmarks
 based on existing and new Australian and International data to raise awareness of productivity
 issues.

Education and Training

This Recognition Working Group has engaged with FMA Australia and the Construction & Property Services Industry Skills Council (CPSISC) as part of a broader campaign to raise the profile of facilities management across the educational spectrum. At the Vocational and Technical Education (VTE) level a pilot scheme for an 'FM Certificate IV traineeship program at VET level' with involvement of industry partners has been investigated.

The FM Action Agenda has established an FM Education & Training framework intended to encourage greater collaboration between the Higher Education and VTE sectors. The innovative project's scope was confirmed with the piloting of one identified functional area, being Sustainability, within this framework. UNE Partnership, University of Sydney and Brookfield Multiplex will collaborate on a 'Workplace Training on Sustainability' program which will commence in July 2008.

During the life of the FM Action Agenda we have seen the establishment of Australia's first undergraduate FM degree programs; combined Bachelor of Construction Management / Bachelor of Facilities Management at Deakin University (March 2007); Bachelor of Property and Sustainable Development (with a major in Asset and Facility Management option) at Bond University (September, 2007); and Bachelor of Built Environment (with a major in Facilities Management option (March 2008) at Holmesglen Institute of TAFE. Other institutions are increasingly introducing FM subjects. All subject to minimum enrolments. Discussions have also progressed with other educational providers, including the prospect of online degree programs.

Further opportunities for FMA Australia to participate at Careers Expos and support IFMA Foundation scholarships have been pursued as a means of informing and encouraging those interested in FM related career paths.

Regulatory Reform

Lack of cross jurisdictional harmony between state and territory regulatory requirements adds significant FM costs to national property portfolios. In response, this Recognition Working Group have undertaken an intensive program of identifying and cross referencing legislation into tabular formats for nine (9) regulatory issues across multiple legislative jurisdictions in order to develop a National Regulatory Protocol recommendation for uniformity. The Working Group has developed a pilot project to demonstrate the benefits of developing FM compliance guides to assist owners, tenants and managers better appreciate the strategic role of FM and the benefits of cross jurisdictional harmonisation of compliance requirements.

The Working Group's focus has been on identifying legislation across each State and the Commonwealth, together with commenting on inconsistencies, and proposing recommended uniformity. However to simply set about compiling a list of legislation would not answer industries need. The adoption of a framework and the identification of minimum appropriate standards based on reviewing the commonality of existing regulations across all tiers of government is recommended. Each area of legislation being referenced to enable it to be readily searchable on a web enabled data base providing clarity on the requirements and reporting processes is needed to enable an ease of understanding of specific risks and efficient compliance.

Maintaining regulatory simplicity and currency will allow evolution into a uniform set of industry Acts and Regulations to evolve. A common compliance information portal could be maintained to ensure the evolution of uniformity in the controls, legislation and regulation by a commitment from industry and government to allow updated legislative changes and standards to be communicated to all those responsible for Managing the Built Environment.

Sustainability

The role of FM in meeting the sustainability challenge is being acknowledged by individuals and organisations realising that their actions have consequences, governments in their policy platforms and organisations recognising the environmental, social and financial benefits of creating and maintaining Green Buildings. This Recognition Working Group have through relevant forums collaborated with ASBEC, CRC for Construction Innovation, Department of the Environment & Water Resources, FMA Australia, GBCA, PCA and, TEFMA. In particular, we have promoted the FM Industry's role in reducing greenhouse gas emissions through improved energy usage within a sustainable Built Environment. Specific contributions have been made to a range of research projects, forums and publications over the past three years.

The proposed deliverable for industry is 'A Practical Guide to Sustainability for Operational Facility Managers'. It is envisaged this Guide will provide a simple and practical framework with which facility managers can implement sustainability measures and assist the FM Industry to play a significant role in a sustainable future. This Guide will be published shortly by FMA Australia.

FM Exemplar Project: Sydney Opera House

The FM Exemplar Project: Sydney Opera House was initiated by the Australian Government's FM Action Agenda, as part of a strategic framework for managing the built environment. The research, was supported by the Department of Industry, Tourism and Resources, and undertaken by the Cooperative Research Centre for Construction Innovation in collaboration with FMA Australia, Sydney Opera House, Transfield Services, Brisbane City Council, Queensland Department of Public Works, CSIRO, Queensland University of Technology, The University of Sydney and Woods Bagot. The project was led by Rider Levett Bucknall on behalf of the CRC for Construction Innovation and FM Action Agenda.

The FM Exemplar Project: Sydney Opera House was completed late in 2006, with the final report integrating the Digital Modelling, Services Procurement and Performance Benchmarking research streams entitled 'FM as a business enabler' published in February 2007. This was followed by a second publication in April focused on the Digital Modelling outputs entitled 'Adopting BIM for facilities management'.

In May at the ide**a**ction 2007 conference gala dinner in Sydney, the CRC for Construction Innovation received the FMA Australia - Rider Hunt Terotech Industry Achievement Award for excellence in facility management strategy and practice for their work on the FM Exemplar Project: Sydney Opera House. The Digital Modelling component of the FM Exemplar Project research also featured in two recent Arup-sponsored international awards – the Jury's Choice category of the American Institute of Architects (AIA) Technology in Architectural Practice (TAP) 2007 Building Information Model (BIM) awards, and the Bentley Awards for Excellence 2007 award for BIM in multiple disciplines.

RECOGNITION FM AS A BUSINESS ENABLER

The FM Action Agenda's strategic phase during 2004 identified a number of key concerns for the industry. The 2005 strategic plan "Managing the Built Environment" noted that 'facilities management was a rapidly developing industry with strong prospects for future growth'. However, despite FM playing a significant role in the delivery of services to business and the community, its greatest challenge was lack of recognition of its strategic contribution.

The FM Action Agenda through its focus of creating a culture of innovation, improving education and training, addressing regulatory impediments and taking up the sustainability challenge has demonstrated FM's contribution to a more "productive and sustainable Built Environment".

During 2007-08 alone, the concluding year of the implementation phase, the FM Action Agenda reached conference audiences in Sydney, Melbourne and the Gold Coast, as well as Shanghai, Kuala Lumpur, New Orleans, Seoul, Sacramento and Manchester. The FM Action Agenda has delivered Recognition across its platforms of innovation, education, regulatory reform and sustainability, along with its award winning FM Exemplar Project report entitled "FM as a business enabler".

PART B 2008 STATUS REPORT

The Facilities Management (FM) Action Agenda's aim was to develop a strategic framework for the growth of a sustainable and internationally competitive Australian facilities management sector. The 20 point action plan within the FM Action Agenda has been developed to facilitate meeting the industry's vision to become 'the foremost contributor to a productive and sustainable Built Environment through excellent and innovative management of facility services'.

It should be noted that it was always anticipated that many of the FM Action Agenda's initiatives would not have defined completion dates. This concept of continuing improvement and expanding opportunities has been incorporated within the 2008 Transition Plan. Hence, our Recognition Working Groups completion targets by Action and the resulting deliverables have not all been set at "100%" for handover. In line with the Implementation Board's wish to ensure that the ideas progress and that the intellectual property is preserved, the Transition Plan generally anticipates that FMA Australia will be the principal future custodian to continue the FM Action Agenda legacy.

The FM Action Agenda: 2008 Transition Plan sets out Implementation Phase achievements, deliverables and recommendations intended to influence the future of the FM industry. The following summarises the Recognition Working Groups status and handover plans by each of the 20 Action item.

Facilities Management in the Australian Economy

The FM industry evolved during the 1980's as a consequence of more widespread outsourcing by business of activities, such as the management and maintenance of buildings. The industry plays a significant role in planning and managing the built environment throughout its life cycle, which has three linked stages: facility creation, operation and disposal. The industry's primary function is providing strategic management advice on the efficient operation of buildings and reducing operational life cycle costs. The industry is also responsible for ensuring that services are delivered in a way which contributes to the productivity and profitability of building occupants, as well as improved returns for owners and investors.

The range of services provided include traditional building services such as repairs and maintenance, security and cleaning, as well as more technical services requiring highly skilled personnel.

ACTION 1


Annually update data on the facilities management industry's contribution to the Australian Economy

As part of the preparation of the FM Action Agenda, the Department of Industry Tourism and Resources commissioned Access Economics to undertake a study on the size of the facilities management industry. The 2004 Access Economics report estimated the facilities management industry contributes \$12.4 billion to Australia's gross domestic product (GDP). This is equivalent to 1.65 per cent of Australia's GDP and includes a direct GDP contribution of \$8.6 billion or around 1.15 per cent of Australia's GDP, and an indirect contribution of a further \$3.8 billion or about 0.5 per cent of Australia's GDP. The Access Economics Report also determined that total employment by the facilities management industry was 172,000 persons in 2002-03. This is equivalent to about 2.1 per cent of Australia's workforce.

The gross value added of the FM industry is determined by subtracting its purchases from its revenues. Access Economics defines the FM industry broadly to include all specified services that could be provided, in principle, by FM firms. The following information is sought from organisations for the statistical update:

- 1. expenditures by users of FM services, which in total equal FM revenue
- 2. cost data for suppliers of FM services, and particularly FM firms.

FMA Australia working with Access Economics has prepared an updated statistical profile for the FM industry for 2005-06 the report was released in September 2007.

Mike Quinlan President of TEFMA Director, Facilities Management Services – University of New England The 2007 report did confirm that the FM industry accounted for combined direct and indirect contributions in 2005-06 of \$13.6 billion of value added, \$13.9 billion in GDP, and (full time equivalent) employment of 180,000 persons. It is estimated that these combined contributions will represent 1.5%, 1.4% and 2.1% of the corresponding gross value added, GDP and employment for Australia.

ACTION 2

Consult with the Australian Bureau of Statistics with a view to obtaining improved data for the facilities management industry

The FM Action Agenda Implementation Board committed to updating the data on the facilities management industry's contribution to the Australian economy and an updated survey was conducted by Access Economics during 2006-07. An application was lodged via FMA Australia to the Australian Bureau of Statistics for the recognition of Facilities Management as a separate industry sector in the future.

Innovation

Achieving growth in the facilities management industry will depend, in part, on fostering a culture of innovation and collaboration in the exchange of information and ideas. Due to the breadth and scope of facilities management, much of the innovation in the industry has been introduced and adapted from other industry sectors, or from overseas.

The creation of an FM Innovation Forum has been explored to foster the exchange of ideas and information, and a web portal established to bring this innovation to industry stakeholders. The Innovation Working Group facilitated the generation and perpetuation of innovative best practice in the FM community. This has been achieved by engaging with key innovators throughout industry and sharing the outcomes.

ACTION 3

Establish a Facilities Management Innovation Forum for the facilities management industry

Following the February 2007 Innovation Working Group (WG) web based survey (82 respondents) hosted by Woods Bagot, focus areas and topics for the development by an FM Innovation Forum were identified. The survey and the results were posted on the FM Action Agenda website. Topics included Services Procurement, Workplace Productivity and Sustainability. The WG presented the findings of the survey at an Innovation Round Table breakfast which was hosted by FMA Australia in Sydney at ide**a**ction 2007.

The Innovation WG have provided considerable intellectual property to FMA Australia in their handover report. In addition there are recommendations and a draft business case for the development of a web based FM Innovation Forum and a national seminar series to facilitate information exchange and promote vocational training.

ACTION 4

Establish a web portal for the facilities management industry to disseminate information and provide feedback on innovation, education and training, regulatory issues, and sustainability

The FM Action Agenda web portal was developed under a grant provided by the Department of Industry Tourism and Resources. The new website was launched on 1 June, 2006 at the FMA Australia's annual conference, ide**a**ction 2006 held in Canberra. The FM Action Agenda website has been maintained since by WinterComms with industry sponsorship.

It is recommended that FMA Australia as custodian be responsible for the future of the FM industry web portal facilitating FM knowledge development and dissemination, ensuring the FM Action Agenda legacy.

ACTION 5

Promote the benefits of innovation and encourage greater industry collaboration and investment in research and development

In line with Actions 3 and 4 the FM Action Agenda initiated a number of projects focusing on:

- Education planning a national training seminar series focusing on 'what is innovation?', to facilitate the FM industry to think more creatively and innovatively.
- Services Procurement a published guideline is planned to encourage improved behaviours and stimulate innovation with regard to materials selection, life cycle costs, risk-reward mechanisms and long term operational performance for end users.
- Workplace Productivity research undertaken into productivity benefits associated with improved training, indoor ecology and industry guidelines have been proposed.
- Sustainability research national and international performance benchmarks and standards to identify appropriate best practice and technologies.

ACTION 6

Highlight the contribution that facilities management makes to productivity by establishing performance measures and 'best practice' benchmarks, incorporating client input, with a specific focus on improving workplace productivity

Research undertaken by the Innovation Working Group has identified that there is increasing corporate, local government and industry association interest in undertaking research into productivity benefits associated with indoor ecology. A project has now been established which assesses the productivity measurement methodology obtained from the Healthy Buildings Forum in Lisbon, Portugal against recent productivity case studies undertaken in projects across Australia. The resulting draft project report could be published as performance measures and best practice benchmarks based on existing and new Australian and International data.

With FMA Australia as the publisher, further work on content and development of case studies is contemplated. Sources of research funding from government and industry have been identified, along with recommendations to collaborate with allied industry research groups such as the CRC for Construction Innovation and the IFMA Foundation.

Education & Training

There is a clearly identified need to ensure that facilities management is seen as a professional career path in its own right, rather than as an adjunct to other professions supported by disparate educational offerings as at present. As part of a broader campaign to raise the profile of FM across the educational spectrum, industry, the Vocational and Technical Education (VTE) sector and universities are collaborating through the Education & Training Working Group (WG) to increase the availability of FM courses at the VTE and undergraduate level.

The WG undertook the task of ensuring ongoing access by industry to highly skilled FM professionals, capable of delivering a valuable service.

An innovative project demonstrating collaboration between the VTE and higher education sectors was initiated, along with an awareness campaign to increase the recognition of facilities management as a career of choice by school leavers. Further opportunities for FMA Australia to participate at Careers Expos and support IFMA Foundation scholarships have been pursued as a means of informing and encouraging those interested in FM related career paths.

ACTION 7

Work with the Construction and Property Services Industry Skills Council to support the provision of vocational education and training for the facilities management industry

The WG has worked with the Construction & Property Services Industry Skills Council (CPSISC) to support the provision and development of Vocational and Technical Education (VTE) for the facilities management industry in the following key areas:

- Supporting the development, implementation and continuous improvement of quality nationally recognised training products and services, including Training Packages through the FMA Australia's engagement with CPSISC; and
- Delivery of the first Certificate IV training in facilities management through RMIT -TAFE in close consultation with various industry organisations.

The review of Training Packages is ongoing, with FMA Australia involved in the process of formal review through CPSISC to ensure a closer fit between VET and the wider FM Education and Training framework.

To ensure continuity of these initiatives the WG's findings, deliverables and recommendations will be provided to FMA Australia and CPSISC at the conclusion of the FM Action Agenda implementation phase.

ACTION 8

Work with Australian universities to increase the availability of facilities management courses at the undergraduate level

The WG has made good progress with Australian universities in increasing the availability of facilities management courses at the undergraduate level. To date the following has been achieved within the life of the FM Action Agenda:

a) Deakin University: Bachelor of
Construction Management / Bachelor of
Facilities Management combined degree*
(5 year program) with early exit option
leading to Bachelor of Facilities
Management (after three years), offered

Students undertaking Deakin's Bachelor of Management and Bachelor of Commerce degrees will be able to undertake a major in FM in their final year from March 2007. Courses marked (*) are accredited by the RICS.

 b) Bond University: Bachelor of Property and Sustainable Development (2 year program) with an optional major in Asset and Facility Management available from September 2007 (subject to minimum enrolments).

c) Holmesglen Institute of TAFE: Bachelor of Built Environment (1 year program following 2 year Bachelor of Applied Science (Built Environment) with an optional major in Facilities Management available from March 2008 (subject to minimum enrolments).

Discussions are continuing in regard to Macquarie University's Bachelor of Business Administration to develop a new specialisation in Facilities Management (current specialisations include Event Management, Hospitality Management, Property Services Management, International Tourism, and Retail Services Management). The University of New South Wales has included some FM subjects within its new Bachelor of Construction Management and Property program.

In view of the need to ensure national coverage the prospect of an online degree program is being investigated. Deakin University and fmedge agreed to collaborate on the development of an online/off campus pathway leading to a Bachelor of Facilities Management. Another possible provider could be the Open University Australia.

In order for this to continue the WG's findings, deliverables and recommendations will be provided to FMA Australia at the conclusion of the FM Action Agenda implementation phase.

ACTION 9

Develop an innovative project that will encourage greater collaboration between the VTE and higher education sectors in the provision of facilities management education

The WG has established an FM Education and Training framework intended to encourage greater collaboration between the Higher Education (HE) and VTE sectors. The innovation project will pilot one identified functional area within the framework by developing a series of work-based learning activities tailored to one or more trial employer groups.

Based on industry consultation the preferred competencies and enabling skills for the pilot has been drawn from the 'Environment, ESD, Energy and Utilities Management' within the Asset Management functional area of the framework.

A draft project plan structure was developed based on using existing industry, VTE and HE courses and modules as well as relevant competencies as defined by PODS.

The innovation is mainly in the delivery strategy and the adoption of a problem-based approach that will provide authentic and relevant learning experiences with a view to delivering targeted professional development courses for the FM industry.

A Project Plan has been finalised involving Brookfield Multiplex Services as the employer and collaboration between UNE Partnerships and the University of Sydney as the education providers to design the pilot scheme for a 'Workplace Training on Sustainability' program which is to commence in July 2008. Beyond this pilot it is recommended that FMA Australia seek CPSISC support to develop further training modules.

ACTION 10

Undertake an awareness campaign directed at those who influence career choice - including school counsellors, career advisers, educators, parents and students - to increase understanding of facilities management as a career

The WG has engaged with education providers and government to capture the key requirements in order to build an effective awareness campaign. There has been considerable effort in understanding the existing avenues available for potential FM students when looking for career options and guidance. The WG has concluded that specifically targeted promotion is likely to deliver public awareness in interest categories which would in turn drive demand for FM industry education; and, that broader education will occur over time. FMA Australia have undertaken to identify appropriate Careers Expos aimed at attracting school leavers into FM related traineeships and courses. In addition other events and required promotional materials have been identified where the recognition of FM could be enhanced.

Regulatory Reform

Government regulations, codes, standards and guidelines in relation to essential the healthy and safe delivery, maintenance and occupation of our Built Environment continue to evolve and owners are required to reassess their obligations on an ever increasing basis. The Regulatory Reform Working Group (WG) has determined that rather than Federal legislation being created that could take years to negotiate, a National Regulatory Protocol that was consistent with State Legislation would be more appropriate.

There is a considerable compliance reporting burden placed on the FM industry. Seeking regulatory reform in order to obtain greater cross jurisdictional harmonisation would assist in improving efficiencies and in turn the availability of valuable FM resources.

Building on the Trotman Report which was commissioned by the FM Action Agenda in 2004 to examine the benefits, costs, impact of likely regulatory simplification for FM compliance.

The following table summarises the subjective ratings of costs, impact and likely regulatory change for the eight (8) selected issues.

This assessment elected asbestos, cooling towers and emergency plans as the three most significant issues for further analysis. In addition it was proposed that the definition of confined spaces be addressed as a separate issue due to its importance to management of buildings, relative simplicity and the potential for achieving a result.

Beyond the eight (8) priority regulatory action areas defined in 'FM Action Agenda: Managing the Built Environment'. In addition in 2006 the Implementation Board endorsed the inclusion of Equality of Access as a ninth regulatory reform focus area, and a Project Delivery Team was formed to deal with this area.

Across industries the current trend appears to favour uniform legislation in relation to matters of national importance. The Council of Australian Governments (COAG) is the peak intergovernmental forum in Australia and supports this view and the imperative to simplify the compliance process. The advantage of uniform legislation is obvious - people and industries affected by legislation, and those who advise on it would no longer need to be familiar with seven different Acts and regulations in order to conduct their business or advise their clients. This is of course before even considering codes that enforced at a local government level.

The WG's focus has been on improving and augmenting these into a concise National Regulatory Protocol recommendation that is consistent with State legislations, in order to promote regulatory uniformity.

ACTION 11

Promote awareness within the facilities management industry of the regulatory requirements applying in three selected areas (asbestos; emergency evacuation plans; and cooling towers)

ACTION 12

Identify the regulatory requirements for a further five (5) identified areas (dangerous goods; fall prevention; confined spaces; plant safety; and electrical inspection, testing and residual current devices)

For Actions 11 and 12 the WG focused on the benefits of the development of a national framework of minimum standards based on the review of the commonality of existing regulations across all tiers of government. It was considered that any national standard should be based on all existing legislation.

A great deal of legislation does not distinguish between the responsibilities of the building owner, occupier or manager. Further it was contended that access to this information is currently excessively difficult to obtain as control of the information is held within various jurisdictions. Creating a basis for regulatory simplicity and currency will allow evolution into a uniform set of industry Acts and Regulations. It is proposed that an on-line centralised portal of compliance information be established and maintained by and for the industry, who will ultimately benefit from the efficiencies achieved.

The WG have prepared a detailed pilot regulatory framework with links to applicable websites and recommendations for further development. FMA Australia will consider how to progress this project initiative with other relevant stakeholders.

ACTION 13

Promote conformity of regulatory requirements and contribute to key areas of regulatory reform

a) Establish the working group with membership sufficiently skilled and geographically spread to assess, define and implement each of the Action items (completed April 2006).

 b) Create stage one awareness strategy and post appropriate links on the FM Action
 Agenda web portal (completed September 2006).

c) Review regulatory requirements for each State, comment on the appropriateness of State regulations and create a recommended National Regulatory Protocol for Action 11 (completed August 2006).

 d) Formulate a communication strategy to promote awareness (completed September 2006)

Sustainability

The FM industry is in a strong position to influence decisions made by business and governments to deliver lower environmental impacts. Hence, there is a need for FM to take a leadership role in raising awareness of the benefits of a more sustainable Built Environment.

Over recent years, there has been a significant macro change in attitudes towards sustainability, driven by the convergence of many factors well beyond the influence of the FM Action Agenda, including the;

- Widespread distribution of Al Gore's film "An Inconvenient Truth"
- Intergovernmental Panel on Climate Change (IPCC), Fourth Assessment Report
- Stern Review Report on the Economics of Climate Change
- ongoing Australian drought and Murray-Darling River system crisis
- Garnaut Climate Change Review for the Australian Government (draft 4 July 2008)

There is now widespread recognition by both the private and public sector of the importance of environmental sustainability and the costs and benefits of climate change mitigation.

Increasingly FM professionals are rather than having to justify or make the business case for sustainability, are now confronted with the question of 'how to be sustainable?' The political, social and economic 'goal posts have moved' in the relatively short life of the FM Action Agenda. Hence, the Sustainability Working Group (WG) have focused not just on the recognising the role played by the FM Industry in facilitating sustainability but on how to achieve it.

The WG have played a role in facilitating recognition of the FM industry's role in delivering a more sustainable Built Environment, and continue its proactive role in key industry and government forums on sustainability to achieve the desired outcomes against Actions 14-17. The global deliverable across these four Actions for industry will be 'a Practical Guide to Sustainability for Operational Facilities Managers'. This will provide a simple framework for Facilities Managers to start on the sustainability path.

ACTION 14

Promote the role of facilities management in responding to increased demand for corporate accountability associated with sustainability performance

The Australian Built Environment contributes to significant Greenhouse gas emissions (23% for residential and non-residential combined, per the ASBEC Climate Change Task Group's report, 'Capitalising on the building sector's potential to lessen the costs of a broad based GHG emissions cut' prepared by the Centre for International Economics), uses substantial quantities of water, produces substantial amounts of waste and influences the productivity of occupiers both positively and negatively. Other sustainability agendas are largely focused on new developments and are ignoring the opportunities available to deliver significant benefits across the existing Built Environment.

Given the recent increased focus on Corporate Social Responsibility (CSR) and accountability demands associated with sustainability performance, it is now common to see corporations and governments adopting sustainability criteria, particularly in relation to their accommodation. The criteria generally being expressed in star ratings under one of the design and or operational performance tools. The Design and Construction Industry is readily adopting this as good practice delivery, but there is still the potential for disconnect with the operational phase of the facility life cycle.

The key outcome for Action 14 is to promote the role of FM in bridging the perceived gap between the promise of design (for example ABGR commitment targets and Green Star ratings) and delivered

ACTION 15

Promote the role of the facilities management industry in key industry and government forums addressing sustainability

The WG has promoted the role of the FM industry in relevant forums including the ASBEC, CRC for Construction Innovation, Department of the Environment & Water Resources, FMA Australia, GBCA, PCA, TEFMA and RICS. In particular, the WG has promoted the role that the FM Industry can take in reduction of greenhouse gas emissions through improved energy usage within the Built Environment. Over the last decade greenhouse gas emissions due to human activity have increased significantly above the Kyoto Protocol target of 108% above 1990 levels, the FM Industry have a key role to play in reducing these emissions from the Built Environment.

ACTION 16

Use the data web portal proposed in Action 4 to disseminate sustainability information

It is intended that once complete that 'a Practical Guide to Sustainability for Operational Facility Managers' will be published in PDF format and available via FMA Australia website and other links.

ACTION 17

Develop a 'business case' model that highlights the costs and benefits of embracing sustainable practices in the use and management of materials; energy; water; waste; and indoor environmental quality, with a particular focus on workplace productivity

The original focus for Action 17 had been to develop or contribute to the business case based environmental benefits rather than purely financial benefits. However, as we are now repeatedly told, 'the debate is now over', hence the key WG sustainability deliverable for industry is 'a Practical Guide to Sustainability for Operational Facilities Managers'. This will provide a simple framework to start them on a sustainability path. It is envisaged this Guide will assist in bridging the intent and reality gap to enable the FM Industry to play a significant role in a sustainable future.

FMA Australia plan to publish a first Edition softcopy version of this Guide in the near future.

Implementation

The 36 months implementation phase has taken a multi-pronged approach to enhancing the recognition of the FM industry and removing impediments to its growth with a 20 point action plan across the Recognition platforms of Innovation, Education & Training, Regulatory Reform and Sustainability.

ACTION 18

Establish an Implementation Group comprising leaders of the facilities management industry to manage the implementation of the Action Agenda

Following the appointment of the Implementation Board by the Hon Ian Macfarlane, MP Minister for Industry, Tourism and Resources in August 2005, the Board has met regularly until it's final official meeting in Sydney on 24 June 2008. During the Implementation Phase the Board formed the **Recognition Working Groups and Project** Delivery Teams and working closely with a range industry stakeholders. All members of the Implementation Board were actively involved in leading the Recognition Working Groups across the key areas to ensure that the FM Action Agenda is delivered. During Year 3 the Board agreed the 2008 Transition Plan benefits and deliverables continue beyond the 36 month FM Action Agenda term.

ACTION 19

Develop a communications strategy to increase recognition of the contribution of facilities management as an industry

The FM Action Agenda has implemented a campaign designed to communicate clear messages about the contribution the FM industry makes in managing the Built Environment. Specifically, the members of the Implementation Board have, over an extended period, met with allied industry groups, and have delivered presentations, given interviews and contributed to industry journals, to further the objectives of the FM Action Agenda and communicate the benefits of facilities management for business and the community as a whole.

The Implementation Board's continued support of the Communications Strategy, combined with improved recognition of FM's contribution, has assisted further media profile and conference presentations. Part C of this report details our Year 3 achievements in terms of;

- 'Media Summary' detailing media releases and coverage given to the FM Action Agenda in various magazines, journals and websites. This excludes the FM Action Agenda website, but includes a regular feature in FMA Australia's Facility Perspectives magazine; and a
- 'Industry Presentations & Forums' list detailing Australian and overseas functions featuring FM Action Agenda materials. To date invitations have been received for future presentations in Beijing, Dallas and Sydney.

In addition to preparing this concluding FM Action Agenda: Year 3 Implementation Phase Report as at 30 June 2008, we established a 2008 Transition Plan detailing for all Actions the achievements and deliverables, along with recommendations for future initiatives.

ACTION 20

Work with relevant government departments and agencies to identify opportunities to raise awareness of the facilities management industry and to consult on relevant government policies and programs The FM Action Agenda has engaged with relevant Government departments and agencies, and media to identify opportunities to raise awareness and enhance opportunities for recognition of the facilities management industry. To this end the Implementation Board members and the Recognition Working Groups are working tirelessly with government departments, industry bodies and the education sector.

In addition three annual reports have been prepared during the Implementation Phase and a 2008 Transition Plan to ensure FMA Australia are positioned to continue the FM Action Agenda legacy.

FM EXEMPLAR PROJECT SYDNEY OPERA HOUSE

The FM Exemplar Project: Sydney Opera House has delivered world class research outcomes for Australia's facilities management (FM) industry.

Last November the CRC for Construction Innovation won at the Association of Consulting Engineers Australia's 2007 Awards for Excellence both a Gold Award of Special Merit and the prestigious Project of the Year Award.

In May at FMA Australia's ide**a**ction 2007 conference gala dinner in Sydney, the CRC for Construction Innovation received the FMA Australia - Rider Hunt Terotech Industry Achievement Award for excellence in facility management strategy and practice for their work on the FM Exemplar Project: Sydney Opera House.

The Digital Modelling component of the FM Exemplar Project research also featured in two recent Arup-sponsored international awards – the Jury's Choice category of the American Institute of Architects (AIA) Technology in Architectural Practice (TAP) 2007 Building Information Model (BIM) awards, and the Bentley Awards for Excellence 2007 award for BIM in multiple disciplines.

Further, Sydney Opera House was awarded UNESCO World Heritage Listing on 28 June 2007.

The FM Exemplar Project: Sydney Opera House was a research project initiated by the FM Action Agenda in April 2005 and completed in November 2006. The project was supported by the Australian Government and conducted by as a Cooperative Research Centre (CRC) for Construction Innovation project with a team of 25 individuals from 10 supporting organisations including FMA Australia, Rider Levett Bucknall, Transfield Services, Sydney Opera House, CSIRO, The University of Sydney, Brisbane City Council, Queensland Department of Public Works, Queensland University of Technology and Woods Bagot. The project was led by Stephen Ballesty of Rider Levett Bucknall and Immediate Past Chairman of FMA Australia.

The FM Exemplar Project utilising one of Australia's most recognisable icons focused on three (3) key FM research streams of digital modelling, services procurement and performance benchmarking. Another distinguishing feature of the project that sets it apart from previous research was the project's objective of linking each of these three streams together to produce an integrated Facilities Management framework. Further the project aimed to develop innovative FM strategies that would showcase FM performance and promote best practice across three (3) research streams;

- Digital Modelling developed an appropriate Building Information Model (BIM) strategy.
- Services Procurement focused on the building maintenance and cleaning services procurement.
- Performance Benchmarking provided a basis to develop Key Performance Indicators (KPI's).

The final report of the FM Exemplar Project: Sydney Opera House integrating the Digital Modelling, Services Procurement and Performance Benchmarking research streams entitled 'FM as a business enabler' was published in February 2007. This was followed by a second publication in April focused on the Digital Modelling outputs entitled 'Adopting BIM for facilities management'.



The FM Exemplar Project: Sydney Opera House represents an excellent opportunity, if FM works on one of the world's most iconic and complex facilities then it can add value anywhere. Importantly the project's findings would be readily 'down scalable' to more conventional and repetitive facilities. This supports the FM Action Agenda promoting the benefits of improved information, service delivery and performance for the benefit of the FM industry, stakeholders and ultimately the community.

DEPT. OF EDUCATION, SCIENCE & TRAINING GLOSSARY DEFINITIONS

Education (1) the process of imparting knowledge or developing skills, understanding, attitudes, character or behaviours. (2) the process of acquiring knowledge, skills, understanding, attitudes, etc. (3) the knowledge, skills, understanding, attitudes, etc. acquired. (4) the field of study concerned with teaching and learning.

Further Education (FE) post-secondary education, including higher education, adult education, and vocational education and training.

Higher Education (HE) post-secondary education offered by a university or other recognised higher education institution, or through Open Learning Australia, leading to the award of a degree or higher level qualification.

Tertiary education formal education beyond secondary education, including higher education, vocational education and training, or other specialist post-secondary education or training; sometimes used to refer only to higher education. Also called post-secondary education or further education

Training the development of skills, knowledge, attitudes, competencies, etc. through instruction or practice

VET - vocational education and training post-compulsory education and training, excluding degree and higher level programs delivered by higher education institutions, which provides people with occupational or work-related knowledge and skills. VET also includes programs which provide the basis for subsequent vocational programs. Alternative terms used internationally include technical and vocational education and training (TVTE), vocational and technical education and training (VTET), technical and vocational education (TVE), vocational and technical education (VTE), and further education and training (FET)

VTE - vocational and technical education; effective November 2005 VTE is the preferred term in Australia, also see **vocational education and training**
